Resolution 2022.01 Enact Federal Legislation to Reduce Food Loss and Waste by St. Patrick's Calgary

Resolved, that national council of The Catholic Women's League of Canada in 102nd annual national convention assembled urges the federal government to enact legislation to reduce food loss and waste in Canada's agri-food, industrial, commercial and institutional sectors.

Action Plan: Enact Federal Legislation to Reduce Food Loss and Waste

- 1. Write letters to the prime minister, minister of environment and climate change, minister of health, minister of agriculture and agrifood, with copies to local members of parliament urging the federal government to enact legislation to reduce food loss and waste in Canada's industrial, commercial and institutional sectors.
- 2. Write letters to provincial, territorial and municipal governments urging them to collaborate with the federal government to reduce food loss and waste in Canada's industrial, commercial and institutional sectors.
- 3. Raise awareness that could include inviting speakers and providing information and resources to members and the public about reducing food loss and waste
- 4. Monitor the federal government's response to the resolution.

This was the only resolution passed at National Convention 2022 and we need to support it by following the Action Plan.
